NOTIFICATION

The District Livestock Mission Committees will be responsible for carrying forward the objectives of the Mission for Project formulation, implementation and monitoring. The office of the Joint Director, Animal Husbandry Department will serve for District Livestock Mission Committees.

The District Planning Committees and Panchayati Raj Institutions will be involved in the implementation of the programme.

The meetings of the District Livestock Mission Committee will be held at least once in every quarter.

Animal Husbandry Department will be the Administrative Department for the District Livestock Mission Committees.
